“The 42-credit baccalaureate program in Native American Studies is intended to provide a basis for employment with governmental agencies or organizations that serve tribal peoples, or serve as a foundation for graduate work in Native American Studies or related disciplines. A solid core of courses will provide students with primary working knowledge of regional tribes, tribal governments, and primary issues impacting Native Americans as well as an introduction to Anishnaabemowin (Anishnaabe language).”

In August 2015 the Tribal Council held one Regular meeting and four Special Council meetings. Actions taken were:

August 6, 2015 Special Finance Council Meeting

- Approved the bid of Copper Country Ford for a Ford F-250 for Eagle Radio in the amount of \$32,200.00. The truck approved in July was no longer available.
- Approved \$15,000.00 for the Baraga Enterprise picnic.
- Loaned the Housing Department businesses up to \$219,000.00 to cover the HUD CD's that were wrongfully used as collateral by the former Ojibwa Housing Authority.
