Victim's of Crime Assistance (VOCA) Coordinator
Full-time, Exempt position

Grade 10 (minimum starting wage = \$23.37/hour)

SUPERVISOR:

Director of Victim Services and Programs

QUALIFICATIONS:

- Bachelor's degree in Counseling, Social Work, and Human Services or related field.
OR
Associate's degree in Counseling, Social Worker, and Human Services or related field and at least two (2) years' experience working in a Victim's Service field.
- Must be able to maintain strict confidentiality laws and policies.
- Must have thorough knowledge of crisis intervention and implement and assist with carrying out a plan of care for survivors.
- Must have skills in oral and written communication to effectively communicate with people at all levels, internal and external.
- Must have a strong ability to analyze information and data, listen effectively to problem symptoms, and resolve complex problems.
- Must have the ability to work independently.
- Previous experience working in the domestic violence field, particularly with state-funded DVS programs, preferred.
- Must be able to work flexible hours, including after hours, and on-call on some weekends.
- Must have strong organizational skills.
- Must be willing to learn the dynamics of domestic violence, sexual assault, stalking, and dating violence.
- Must be willing to learn the Tribal-Federal judicial system, policies, and laws related to domestic violence and sexual assault.
- Experience working with Native Americans and knowledge of Tribal traditions and culture is preferred.
- Must have a valid, unrestricted driver's license and be insurable and able to operate fleet vehicles.
- Must be able to obtain a satisfactory clearance in accordance with the Indian Child Protection and Family Violence Prevention Act Background Investigations Policy.
- Employment is contingent upon the satisfactory result of a Security Background Check, pre-employment drug testing, and a pre-employment physical.

INDIAN PREFERENCE:

Preference will be given to qualified individuals of American Indian descent.

VETERAN PREFERENCE:

Preference will be given to qualified Veterans who do not have bad conduct or dishonorable discharges (need DD214).

MANDATORY REQUIREMENTS:

CPR Training, Universal Precautions, TB Skin Test, Medical Safety Device, Mandated Reporter

DUTIES AND RESPONSIBILITIES:

1. Provides crisis intervention, advocacy, and trauma-informed supportive services for victims/survivors of crimes with a primary focus on sexual abuse, domestic violence, dating violence, stalking, and human trafficking.
2. As a professional advocate, has a prime responsibility for assessment, planning, and carrying out the treatment program for individual clients and for groups of clients.
3. Provides case management including analyzing files, developing action plans for cases, and monitoring case progression.
4. Works with survivors to develop their individual safety and treatment plans, including personal protection orders.
5. Establishes and maintains cooperative working relations with community agencies, schools, courts, and other agencies for timely job completion.
6. Counsels, advocates for, and provides trauma-informed supportive services for victims of crime.
7. Will promote positive interpersonal relationships with staff members, administrators, other professionals, and the public (such as federal agencies, federal advocates, probation, FBI, and FBI advocates).
8. May assist with program planning, development, implementation, and evaluation.
9. Completes consultation and program integration for all discipline providers.
10. Responsible for maintenance of the VOCA program, IE, PMT, and annual report, through EGrams.
11. Must attend continuous training in domestic violence, sexual assault advocacy, and other related areas.
12. Assists in training and staff development of volunteer/intern advocates
13. Assists in the administration of the agency's DOJ/OVC grant program; participates in the establishment of the policy; assists in program planning and the establishment of standards of practice.
14. Prepares and/or assists with completing the fiscal year OVC Program application and reporting.
15. Communicates, both orally and in writing, with others for timely job completion.

16. Communicates with the team lead on a regular basis and completes a monthly report.
17. Participates in community outreach activities, including the annual Powwow, KBIC Health System events, and KBOCC events to promote the VOCA program and victim compensation program.
18. Participates in Multidisciplinary Team meetings with Social Services Department, Police Department, and U.S. Attorney's Office.
19. Must be available to assist when called by Law Enforcement for Victims of Crime Assistance, as needed.
20. Must become a member of the Missing and Murdered Indigenous People Community Response Plan and Team.
21. Other duties as assigned by supervisor.
