

REPLEVIN PROCEDURE

- 1. Claimant must complete and serve *Notice to Deliver Personal Property to Claimant Form* to Defendant. Proof of service must be provided to Court. The Defendant has two (2) days to deliver personal property as described to Claimant.**
- 2. Claimant may File *Civil Complaint for Replevin* after two (2) days have passed and if Defendant has not delivered said personal property as instructed.**
- 3. Hearing for replevin shall be scheduled no more than three (3) business days after filing of *Civil Complaint for Replevin*.**
- 4. Filing fee \$40.00**
- 5. Refer to Title 34 in the tribal code at www.kbic-nsn.gov then go to Tribal Governance then Tribal Code.**
